A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF YORK IN THE COMMONWEALTH OF PENNSYLVANIA, APPROVING AN AMENDMENT TO THE CONSOLIDATED PLAN ANNUAL PLAN AND BUDGET FOR FISCAL YEAR 2008 FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM, AND APPROVING AN APPLICATION FOR FINANCIAL ASSISTANCE UNDER THE U.S. DEPARTMENT OF HOUSING & URBAN DEVELOPMENT'S SECTION 108 LOAN GUARANTEE PROGRAM

WHEREAS, under Title 1 of the Housing and Community Development Act of 1974 and the National Affordable Housing Act of 1990, as amended, the Secretary of Housing and Urban Development is authorized to extend financial assistance to communities for activities which will principally benefit low and moderate income individuals and families; aid in the prevention or elimination of slums and blight in the community; and/or meet other community development needs having a particular urgency; and

WHEREAS, the City of York is a grantee and recipient of Community Development Block Grant Program (CDBG) funds under Title I of the Federal Housing and Community Development Act of 1974, P.L. 93-383, as amended, and as such is eligible for funding under HUD's Section 108 Loan Guarantee Program; and

WHEREAS, the City of York wishes to finance certain CDBG street improvement and community facility improvements with a Section 108 loan from the U.S. Department of Housing and Urban Development; and

WHEREAS, the City of York has prepared an amended FY 2008 Annual Action Plan in compliance with 24 CFR Part 91 "Consolidated Submission for Community Planning and Development Programs," outlining federal resources expected to be available to the City and the activities the City will be undertaking during the next program year to address priority community development and housing needs as identified in the City's Five year Consolidated Plan; and,

WHEREAS, the FY 2008 Annual Action Plan and application for Section 108 loan guarantee assistance was available for citizen review and comment for a period of thirty (30) days; and

WHEREAS, the City has otherwise fulfilled the requirements of its Citizen Participation Plan relative to this program amendment and application for financial assistance under HUD's Section 108 Loan Guarantee Program, including advertising and conducting two public hearings.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of York, Pennsylvania as follows:

1. The amended FY 2008 Annual Action Plan and Application for Section 108 Loan Guarantee assistance as set forth in the schedule of activities and funding amounts, attached hereto and made a part hereof, are hereby approved. The City Clerk is hereby directed to file a copy of the said amended Action Plan and Section 108 loan application with the minutes of this meeting.
2. That it is cognizant of the conditions that are imposed in carrying out the proposed activities with federal assistance under the Community Development Block Grant Program.

3. That the Mayor is authorized and directed to file the amended FY 2008 Annual Action Plan and the Application for Section 108 Loan Guarantee assistance with the U.S. Department of Housing and Urban Development and to provide such assurances, certifications, additional information or documents required by said agency.
4. That the Mayor is further authorized to execute any agreements pertaining to said loan guarantee, and to otherwise act as the representative of the City of York in all matters relating to this application and any award, which may result from this application.
