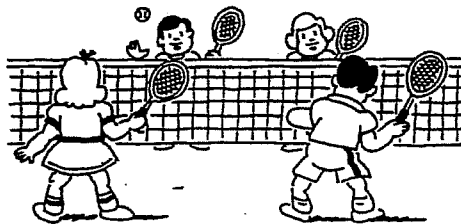


# TENNIS FOR KIDS

Initial registration time is 8:30 - 9:00 a.m., June 21, 2010 at the site of your choice. However, Tennis For Kids will accept children through July 16, 2010.

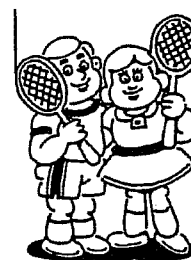
